For use of parts of a container it is recommended to homogenize the products first.

Storage Stability: Very Good.

Keep container tightly closed, in a dry, cool and well ventilated place and out of direct sunlight.

Keep container in upright position in order to prevent leakage.



Shelf Life: Can normally be stored in the unopened original packaging at a cool, dry, well ventilated place, away from the sun and the light, for at least 36 months.

Store in: Steel Stainless or HDPE (High Density Polyethylene).
